

1 ORGANISATION PROFILE

1 IMPACTS ACHIEVED

Workshops, Seminars and Side Events

1. Roundtable on "Sustain-Ability Day" as part of the ETHZ's annual "Digital Art Week" (DAW) programme in Singapore, 6–19 May 2013, Singapore.

At the occasion of DAW Singapore, Prof. Raymond Saner developed a symposium programme focusing on the Sustainability issue of today's world on the 11th May, 2013 in Singapore.

2. Table Ronde on "Soutien Mutuel pour la Durabilité", organized together with the International Association for Sustainable Commerce and Development (COMDEV), 2nd July 2013.

The Director General of the International Telecommunication Union, together with representatives from other international organisations (ILO and UNDP), university and company were gathered to discuss the issue of health, waste treatment, poverty, youth unemployment in the LDCs.

3. Study Visit by the President of National Chengchi University, 18–20 September 2013.

CSEND invited potential partners to meet with President Wu and the NCCU delegation to discuss joint teaching programmes in Geneva for the students of NCCU. Meetings were held at CSEND with Prof. Susan Schneider, Prof. Raphael Cohen and Mr. Michael Handley.

President Wu also visited the UNIL in Lausanne to discuss future exchange programme between the two universities.

4. International Conference on Social Innovation and Social Entrepreneurship, 30 October, Taipei.

CSEND was requested by the Taisan Innovation Centre, Bureau for Employment and Vocational Education and Training, Commission of Labour Affairs, Republic of Taiwan to put together a panel of international speakers from Europe to discuss the challenges and trends in social innovation and entrepreneurship.



Members of penal consisted of Dr. Rainer Geiger, retired Director, Investment Division, Organisation for Economic and Development Cooperation (OECD); Mr. Art Clay, Artistic Director, DAW International, ETHZ; Prof. Dr emeritus Raymond Saner, International Management & Organisation, Basle University and Lichia Yiu, President of CSEND.

A side event also took place during this visit to explore potential partners to be engaged in the planned DAW 2015.

- 5. To celebrate its 20th anniversary, CSEND organised a three-day roundtable to reflect on major issues that CSEND has been working on.
 These issues were:
 - Labour market, technological innovation, global supply and chains
 - Democratisation of policy space
 - Social contract and social fabric
 - Trade economics and international relations
 - Private-public good concept (PPP)
 - Governance
 - War & peace and humanitarian standards.
 - War & peace and humanitarian standards.

Altogether, more than 50 colleagues from the USA, China, Dubai, European countries and Switzerland participated in these series of roundtable.

2 KNOWLEDGE TRANSFER AND OUTREACH

2.1 Swiss Network for International Studies (SNIS)

CSEND initiated a research consortium with The Swiss Tropical and Public Health Institute (Basle), Graduate Institute (Geneva), Franklin College (Lugano) and Future UN Development System (FUNDS) Project (Geneva & New York) and together won a research grant from SNIS for a two year research project (2013–2014).

This research project, entitled "Trends and Influence of Private and Non-Traditional Finance on Global Health Initiatives and Development Goals in Resource-Constrained Countries" runs from 2012–2014. As part of the consortium, partner organisations are obligated to contribute in kind to budget for the fulfilment of the agreed research objectives.

2.2 Sciences Po Capstone Research Project

CSEND put forth a search project focusing on the monitoring and evaluation systems applied by the selected philanthropic organisations in the health sector. This search project was carried out by a team of five students from the MPA programme of the Sciences Po. Prof. Raymond Saner served as the advisor to the group.

CSEND is member of a research group called Global Action Network Competencies which regroups social scientists and organizational scholars from North American and Europe. The goal of the ongoing research group is to define the competencies needed to successfully design and implement cross-sector alliances and networks, started in June 2012– on going.





3 INTERNSHIP PROGRAMME

CSEND continued its internship programme by providing internship placement though Boston University and University of Venice. A total of five interns participated in this 2 month internship programme in 2019.

3.1 Policy Research Papers by CSEND interns

A total number of seven background papers were completed by interns as inputs into CSEND's research programme and simulation excercises. These research projects were part of the course requirements of their study programme in Geneva. The topics were chosen by CSEND and the research were mentored by CSEND team.

- e. "Human Rights in Free Trade Agreements" initial mapping by Laura Wojcik. An initial scanning of the existing FTAs and its human rights provisions.
- f. "Lesotho, A Tourism Destination: An Analysis of Lesotho's Current Tourism Products and the Potential for Growth", back ground research and draft by Marcus R. Lee.



- g. An analysis of existing tourism assets in Lesotho and potentials for developing higher value tourism products.
- h. "Private Financing in Global Health Partnerships: Influences and Choices", research and report prepared by Sarah Zeis.
- i. The Effectiveness of Aid Targeting Malaria, Tuberculosis and HIV/AIDS Prevention and Treatment in Ghana, Michael Davisson.
- j. An analysis to trace the influence of the inclusion of private finance in the global health development context through its involvement in current public private partnerships throughout the 21st century.

IMPACTS ACHIEVED

CSEND initiated a response to the call for tenders for the new MOPAN evaluation framework. The Multilateral Organisation Performance Assessment Network (MOPAN) is a network of 19 donor countries¹ with a common interest in assessing the organisational effectiveness of the major multilateral organisations they fund. MOPAN members agree to carry out joint assessments, share information and draw on each other's experience in monitoring and evaluation.

The assessment is intended to generate relevant and credible information about multilateral organisations to assist MOPAN members in meeting domestic accountability requirements. It also aims to promote dialogue between MOPAN members, multilateral organisations and their direct partners. MOPAN assessments focus on whether organisations have in place four dimensions of organisational effectiveness: strategic, operational, relationship and knowledge management. Since 2012 MOPAN also assessed the results achieved by multilateral organisations

CSEND formed a consortium consisting of Whiteshield Partner (London), OrgVitality (New York), Conseils sans frontières (Paris), Azimut (Poland), Clingendael Institute of International Relations (The Hague) and FUNDS (London, New York). The competition was fierce, over 300 tenders' were submitted. CSEND's consortium unfortunately did not win the tender but the preparations of the tender generated substantial insights into the working of International Organisations which will be useful for future research.

2. Interministerial trade policy coordination and consultation, Dhaka, Bangladesh

CSEND Director Raymond Saner designed and implemented a workshop for Bangladeshi senior civil servants from ministries linked to trade policy. The trainees were familiarized with the basic concepts of interministerial coordination and public private consultation in international trade and trade policy and related instruments. In this context, reviews were made to showcase country examples from both developed and developing countries in terms of specific approach to enhance trade performance through strengthening trade policy coherence, ownership, transparency and stakeholder engagement.

3. Trade Facilitation and Transport Systems

The static and dynamic effects of regional economic integration, fragmentation of global trading system and intensified global value chain integration could act as both promoting and constraining factors. Effective and broad based trade policy formulation will foster national competitiveness and improve on the trading capacities of the country. The IMC and PPC training served the objectives of enabling the participants to translate the theoretical background and global experiences to Bangladesh's trade policy formulation process. Moreover, this training also provided an opportunity to raise collective awareness the centrality of interministerial coordination (IMC) and public private consultation (PPC) in trade policy making, implementation and monitoring process and necessitate the institutional discussion in better respond to the trade governance demands posted by changing global, regional and national context.



1 IMPACTS ACHIEVED

The negotiations on the Post-2015 development agenda centred on the scope of the post-2015 development agenda and the means of financing these development goals, also known as Sustainable Development Goals (SDGs). The related deliberation and negotiation were launched in 2014 and continued into 2015 in earnest. Two separate UN processes took place to determine the SDG framework namely the HLPF (High Level Political Forum) and the OWG (Open Working Group). In addition, various stakeholder groups (NGOs, Business, Women, Academic Institutions, farmers, municipalities, youth and Child, handicapped) represented by the major groups within the ECOSOC and International Organisations were all engaged with their own consultations and discussions, and provided substantive inputs on what issues and priorities should become the core features of the SDGs or 2030 Development Agenda.

CSEND team conducted a seminar on "Review and Monitoring of SDGs after 2015: Models, Methods, Governance" on 29th June 2015 at the UN Headquarters during the SD-Learning 2015 organized by UN DESA and its SD Learning section. This one week learning event ran along side of the High Level Political Forum in New York. Training material has been uploaded on the website of CSEND and that of UN ECOSOC.

Prof Saner and Prof Yiu together with the CSEND representatives Ellen Raider MA, Dr Roland Bardy, Robert and Sarah Kolodny and Prof Judy Parker participated in the seminar. Prof Saner discussed the 2016 Global Sustainable Development Review (GSDR) with colleagues from UN-DESA. The 2016 GSDR will focus on SDGs and poverty reduction ("leave no one behind"). Prof Saner was invited to contribute to the new theme as drafting member and as potentially a co-author of chapters of the new GSDR.

Regional Consultation Meeting on Financing for Development (20 March): Prof Lichia Yiu contributed to the drafting report of this meeting. The key points



made were on the role of private sector in the financing of development through Private Public Partnerships, need for transparency, better data through systematic monitoring, and need for institutional learning and innovation.

On 25 June, 2016CSEND moderated a Library Talk event organized by the UN 1% Development Fund. A presentation on How Private Development Assistance can contribute to end extreme poverty by 2030 (SDG Goal 1) on 25th June 2016 at the Library Events Room, Palais des Nations.





2 KNOWLEDGE TRANSFER AND OUTREACH

CSEND contributed to the concept development for an International Conference on "The Internet as a Global Public Resource", held in Malta on 29–30 April, 2015. Prof. Lichia Yiu participated as a panel speaker and gave speech on the need to develop sustainable development data as public good to support citizen participation and institutional innovation for achieving the 2030 Development Agenda. This conference was organised and hosted by the Diplo Foundation.

CSEND representatives in New York have networked with the Women's Major Groups on issues related to equal rights and anti-discrimination at the work place. A common position was established on the needs to disaggregate data collected for SDG implementation by stakeholder groups and by location.

CSEND organized a Working Session on "BioTrade for Inclusive Growth: What works and what challenges persist" during the WTO Public Forum 2015 in Geneva on 2nd October. Objective of this Working Session was to highlight the need to achieve fair benefits sharing in one of the less visible aspect of the bio-diversity based trade of natural ingredients for the pharmaceutic and wellbeing sectors. Fair benefits sharing as stipulated by the Nagoya Protocol of the Convention on Bio Diversity, once implemented, will support both environmental and social objectives by providing sustainable livelihood through protection of bio diversity and good harvesting practices. This session was co-organised with the United Nations Conference on Trade and Development (UNCTAD).

1 IMPACTS ACHIEVED

Raymond Saner served as a member of a **team of evaluators** in Brussels. The team was given the responsibility to assess the quality of proposals for development projects in OCTs (Overseas Countries and Territories). In total, 20 country projects were evaluated.

Raymond Saner developed a SDG compatible grid to assess the compliance of PPP case studies (good practices) with the SDG criteria. 20 case exampls of PPPs were analysed. Prof Saner served as Commentator for the session.

10th Session of the Committee on Innovation, Competitiveness and Public-Private Partnerships held a High-level Substantive Segment Meeting on Public-Private Partnerships and Innovation in Support of Sustainable Development. Prof Raymond Saner was invited to be one of the panellists of the Session 1: Draft guiding principles for good governance in People-first Public-Private and Civil Society Partnerships for the Sustainable Development Goals of the first day.

CSEND co-organised with the International Association of Applied Psychology a UN Library Talk entitled "What kind of sustainable education for our common future?" to launch a new publication on "NÉOLIBÉRALISME ET ÉDUCATION" by Jean Luis Chancerel and Sacha Varin (2015) in collaboration with NORRAG (Network for International Policies and Cooperation in Education and Training).

Together with the Global Health Centre at the Graduate Institute and other partners of the SNIS project 2015, CSEND organised a public event with a theme "Influence of private financing on global health initiatives". Both Prof Raymond Saner and Prof Lichia Saner-Yiu were speakers at this event.

CSEND members contributed to the Public Forum at the WTO acting as speakers in different panel session, e.g. Inclusive Digital Trade and Sustainable Development (Diplo Foundation), Informal Trade, CSEND also organised a session focusing on "Inter-Ministerial Coordination and Consultation as Keys to Successful & Inclusive Trade-Policy Making in LDCs". A total number of 10 speakers made inputs to this session.

CSEND President and Director served as discussants for the Round Table on SDG 4, Ensuring full and equal opportunity to a quality education and lifelong learning for all. This Round Table took place within the 7th Conference



on Education Diplomacy & SDGs organised by Olga Kutuzova. Prof Raymond Saner and Prof Lichia Saner-Yiu made a presentation on "Triple bottom line of the SDGs: (economic, social, and environmental sustainability) – the need for life-long learning, learning partnerships, critical thinking and ethical sense of citizenship".

Prof Raymond Saner was invited to speak at the "Safe a Life Initiative" (SALI) conference on the theme "Public-NGO Partnerships in Fragile and Conflict-Affected Contexts" in Doha, Qatar.

Prof Lichia Saner-Yiu was invited to speak at the Symposium on Organizational Learning and Urban Innovation – Mega City Governance and Beijing-Tianjin-Hebei Collaborative Development. 1 IMPACTS ACHIEVED

Prof. Saner was invited to speak at the International Symposium on "Implementing the 2030 Agenda for Sustainable Development and the SAMOA Pathway in Small Island Developing States – SIDS: Equipping Public Institutions and Mobilizing Partnerships" in Nassau, Bahamas.

Prof Saner was invited key note speaker at regional meeting organized by The United Nations (UN) which focused on the theme: "Caribbean Development – The 2030 Agenda in Perspective". The focus of his keynote speech was "how to finance the SDGs".

CSEND Representative Prof Raymond Saner & Lichia Yiu were invited to participate in the International PPP Forum: "Implementing the United Nations 2030 Agenda for Sustainable Development through effective, people-first Public-Private Partnerships", at the City University of Hong Kong. Prof Saner contributed to the Plenary Session I on SDGs 16 and 17 – The importance of building effective, accountable and inclusive institutions (SDG 16) in order to strengthen the means of implementation and revitalise the global partnership for sustainable development (SDG 17).

1 IMPACTS ACHIEVED

Contributed to the Open-Ended Working Group on Ageing during the 9th **Session** – Submitted a formal statement both verbally and in writing form promoting a life course approach for the attainment of economic, social and cultural rights of the older persons. This policy advocacy also posited the need to create lifelong learning and gainful participation in the labour market and in enterprise development during different stages of the life course.

Nominated to the Technical Committee (TC) 314, International Organisation of Standardisation (ISO) on Ageing Society. – Representing the SNV (Swiss Norm Organisation) to participate in the drafting of quality management standards in dealing ageing workforce in the organisation (Working Group 1) and dementia (Working Group 2).

Contributed to the international discussion on **data based monitoring and institutional learning** to achieve PPP related SDG Target 17.17, "Encourage and promote effective public, public-private and civil society partnerships, building on the experience and resourcing strategies of partnerships". Activities for this advocacy involved active participation in the working session of the UNECE International PPP Forum and PPP Business Advisory Board. Additionally, liaised with the UNCTAD and the members of the United Nations Statistic Commission concerning the existing indicator for SDG 17.17 in order to improve the classification of 17.17.1 from Tier 3 status to better defined methodology and data collection.

Promoting the Social and Economic Rights of Older Persons. In 2017, CSEND organised a United Nations Library talk on "Ageing with dignity" as a response to the request of a partner organisation, Kyoto University. Through this international exchange, the full implication of rapid ageing in many countries, developed and developing, became visible to the audience. Therefore CSEND joined the NGO Committee on Ageing in Geneva which led to participation in the working session of the Open Ended Working Group on Ageing in New York in 2018.

As an ECOSOC accredited organisation with consultative status, CSEND has the right to submit statements to the OEWGA (Open ended working group on ageing) and therefore presented a verbal statement from the floor in addition to the submission of a written text addressing the need to ensure the rights of the older persons' continued gainful participation in the labour market and in enterprise development during different stages of the life course.



A second statement was distributed on the floor calling for space making and intergenerational cooperative housing for sustainable ageing, inclusive communities and autonomy and independence of the older persons.

In addition to becoming part of the NGO Committee on Ageing, CSEND also partnered with the National Interdisciplinary Institute on Ageing of the Southwest Jiaotong University in Chengu to promote the approach of active and health ageing as recommended by the WHO and joined the UNECE Standing Working Group on Ageing as a NGO observer.

CSEND agreed to provide support to the Centre for Diplomatic and Strategic Studies (CEDS) Paris, Dakar Campus, Senegal in research supervision of its doctoral student, Mrs Mariam Aidara Monhamdy, a senior Mauritanian civil servant. The title of her dissertation was "The Islamic Republic of Mauritania and the Achievement of the 4th Sustainable Development Goal by 2030". Prof Lichia Yiu was the coach mentor to Mrs Monhamdy.

CSEND continued its internship programme by providing internship placement though Smith College and Boston University. A total of five interns participated in this 2 month internship programme in 2018.



1 IMPACTS ACHIEVED

1.1 Policy Propositions.

a. **Representatives of CSEND** joined by the Greycells President made a verbal motion supported by a written statement during the Twelfth Meeting of the Working Group on Ageing, Economic Commission for Europe (18–20 November). Key message of this statement focused on the need to set up an Expert Group on Ensuring Digital Inclusion and Digital Literacy of Ageing Population.

CSEND/Greycells initiative has been listed with other civil society group initiatives. They were:

- EURAG Conclusions and recommendations of an international Forum on "Lifelong Learning – The Right of Access to Education for Older Persons"
- HelpAge Global Refugee Forum Pledging Guidance
- Red Cross Serbia Taking Action on Social Inclusion of Older People
- b. A statement was submitted as civil society organisation to the 2019 Conference of the UNECE Team of Specialists on Innovation and Competitiveness Policies on a "Smart and Sustainable Cities: The Role of Governance and Innovation Policy" (5–6 December). CSEND statement was based on its research finding through the review of 2019 Voluntary Local Reviews (VLRs) presented during the UN HLPF September session in New York and posited it in the stated definition of smart and sustainable cities by the UNECE (https://www.unece.org/index.php?id=52275) and the Voluntary Local Review Declaration during the 2019 UN Assembly.

Both points to the need to effectively measure sustainability of cities. CSEND statement points to the lack of common application of the SDGs terminology and indicators making it complicated for global city sustainable development review. Actions are urged for the UNECE region to remedy.

c. **CSEND liaised with the UNECE Real Estate Market Advisory Group (REM)** to insert SSE into its Policy Framework for Sustainable Real Estate Markets (2019) as a key element to the Right of Ownership and presented in the footnote 30. Contribution by Prof Raymond Saner was acknowledged in this publication (p.5).

1.2 Standard Setting.

Contributed to the drafting of **ISO 23617: CD, "Ageing Societies – Guidelines for an Age Inclusive Workforce** (CD Stage)" for the Technical Committee (TC) 314 and attended the monthly working sessions and provided technical and editorial comments on record. Prof Lichia Yiu joined the face-to-face working session in Berlin in June. The final WG meeting in Sidney gave the standard a final shape and a Committee Draft was duly submitted for the approval of TC 314 members by voting in December.

Developed a **service quality assessment** standard (SQAF) on institutionalized ageing care, which focused on non-medical care for the older persons. Consultation took place with different expert groups for the drafting of SQAF. This standard has been piloted in China by the National Interdisciplinary Institute on Ageing (NIIA) in Chengdu. Action plan for dissemination of SQAF in China was agreed.







2 KNOWLEDGE TRANSFER AND OUTREACH

A half day **CSEND team seminar** was held at the Teachers College, Columbia University. All members of CSEND Team in New York attended this meeting. Prof Carol Huang of State University of New York was invited to participate as a special guest. The discussion focused on how to influence the global policy making more effectively and where to concentrate the collective energy. It was also highlighted that inequality has become one the major drivers for malcontent and social conflict around the world. Inclusive economic opportunities and fair distribution of benefits are two sub-themes to the social equity narratives.

Similar to the issue of discrimination against women, exclusion of the other, some times in the form of ageism, requires not only public awareness campaign and structural adjustment. The group agreed that transformative education could be one of the tools to deploy. Of which Prof Victoria Marsick and Prof Judy Paker are the experts in this regard.

CSEND representative, Prof Raymond Saner, was invited to preside over the 4th Workshop on Human Capital. The workshop was organized by the Euro-African Institute of Economic Law (INEADEC).

CSEND representatives led by Prof Virginia Schein participated in the NGO Committee on the Status of Women, entitled "Navigating Commission on Status of Women" in New York.

CSEND was invited by the Ambassador of Republic of Benin in Switzerland to attend a High Level Dialogue on the Environmental Laws: Challenges and prospects" during the 40th Session of Human Rights Council.

Prof Virginia Schein accompanied by Tiffany Chan represented CSEND and participated in the 63rd Commission meeting organised by the Commission on the Status of Women. Specifically, the following sessions were attended:

- Modern Slavery and Human Trafficking: Effective Responses for Women and Girls (11 March)
- Tracking The Walk: Measuring Progress On Women's Economic Empowerment (11 March)
- Closing the Gender Pay Gap (11 March)



- Townhall Meeting with the United Nations Secretary-General António Guterres and Civil Society on the Margins of CSW (12 March), hosted by Executive Office of the United Nations Secretary-General and UN Women
- The Gender Effect of Leave and Care Policies stronger with Dads involved! (12 March) hosted by the Prime Minister of Iceland and the Nordic Council of Ministers
- The Future of Women at Work: A Road Map for Gender Equality and Decent Work (12 March), organized by the ILO, Uruguay and Belgium

International Policy Conference on "Making a Difference: Measuring and Understanding the Impact of Innovation Policies and PPP Projects on Achieving the Sustainable Development Goals" was held by the UNECE Committee on Innovation, Competitiveness and Public-Private Partnerships. Prof Raymond Saner was invited to be part of the panel discussion on "Why we need to measure the sustainable development impact of innovation policies and PPP projects". This question was raised due to the assumption that not all PPPs were fit for purpose for the SDGs. This premise itself needed to be critically reviewed.

Concurrently, the WSIS Forum 2019 took place at the International Telecommunication Union. During the 2019 Forum, CSEND not only hosted a special Session but also the visit of Prof ZHOU Xiao Hong. From the Tongyi University, Shanghai. The theme of WSIS Forum 10 (2019) was "Information and Communication Technologies for Achieving the Sustainable Development Goals". This session was moderated by Ms. Roxan Widmer-Illiescu, Senior Programme Officer, Digital Inclusion

A policy debate session was organised to celebrate the ILO Centenary Anniversary by reviewing the work and policy recommendations by the ILO Global Commission on the Future of Work published on how to shape a future with social justice. In an era of immense change in all areas of human life, particularly with regards to the way work is done. New technological opportunities have emerged with the potential to create but also automate jobs. Innovation, particularly in industrialised economies, has allowed for more flexible working arrangements. It was observed that the pace of change and the policy responses have yet to be more sufficiently effective and address the impact on vulnerable groups, such as older persons.

Prof Virginia Schein, representative of CSEND, gave a talk on "Women at the Top: From Gender Bias to Gender Balance" during the 12th Annual Psychology Day at the United Nations, entitled "The Time is now: Psychological Contributions to Global Gender Equality. This event was organised by the Psychology Coalition of NGOs Accredited at the United Nations and sponsored by the Permanent Mission of Palau to the United Nations and the Permanent Mission of the Dominican Republic to the United Nations. Ambassador Katalin Bogyay, Permanent Representative of the Permanent Mission of Hungary made the Opening Remark.



CSEND Representative Prof Raymond Saner was invited to give a presentation during the Forth International PPP Forum: "The Last Mile: Promoting People-first Public-Private Partnerships for the UN 2030 Agenda for Sustainable Development", at the Palais des Nations. Prof Saner gave his talk during the Session 3 on "UNECE Standards, Recommendations, Guiding Principles and Declaration: Setting the Bar Higher – Improving Implementation and Spread of People First Models" on 7th May.

The global platform for Disaster Risk Reduction in Geneva. CSEND representatives attended the Global Forum that focused on the adoption and implementation of the Sendai Framework for Disaster Risk Reduction (2015–2030) so that countries could raise their resilience in the face of climate change and correlated catastrophes and man-made disasters. The First session of the Open-Ended Intergovernmental Working Group to elaborate on the Content of an International Regulatory Framework, without Prejudging the Nature thereof, Relating to the Activities of Private Military and Security Companies on its First Session. Beris Gwynne and Katherine Kramer represented CSEND attended selected sessions in order to assess the existing political will in moving the negotiations of an international regulatory framework.



United Nations Research Institute for Social Development (UNRISD), a member of the UN Taskforce on Social and Solidarity Economy (UNTFSSE), organised an International Conference on "Measuring and Reporting Sustainability Performance: Are Corporations and SSE Organisations Meeting the SDG Challenge?". It was noted that the effectiveness of sustainability measurement and reporting has improved significantly in recent decades due to several factors namely: many new standard-setting initiatives and reforms of existing tools and models, e.g., risk assessment, life-cycle assessment, cost-benefit analysis, ecosystem-service valuation, triple bottom line report, environmental, social and governance (ESG) reporting, integrated assessment models, the multicapital approach and present and future scenario tools. Despite these methodological innovations, the question remains whether current measurement and report models are adequately fit-for-purpose to address the evolving context of 21st century reality. In view of the centrality of monitoring (SDG 17.19) in the work of CSEND and its attempt to promote institutional learning and innovation through effective monitoring, representatives attended this conference with avid interest.

Ahead of the High Level Political Forum on Sustainable Development (HLPF) which was held on 9–18 July, "Together 2030" launched its position paper with key messages to governments and stakeholders engaged in the follow up and review of the 2030 Agenda and urged for greater ambition. Dr Roland Bardy,



CSEND representative in Vienna, attended the session. The SDG Goals that were reviewed during the July HLPF session were:

- Goal 4, Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all
- Goal 8, Promote sustained, inclusive and sustainable economic growth, full and productive employment and decent work for all
- Goal 10, Reduce inequality within and among countries
- Goal 13, Take urgent action to combat climate change and its impacts
- Goal 16, Promote peaceful and inclusive societies for sustainable development, provide access to justice for all and build effective, accountable and inclusive institutions at all levels, and
- Goal 17, Strengthen the means of implementation and revitalize the global partnership for sustainable development.

The CSEND delegation participated in the 2018 High Level Political Forum in New York. Besides participating in various Voluntary National Review sessions, CSEND delegates also attended some of the side events with specific thematic foci, e.g., City, Business, Consumption, Tourism, PPPs and the launching of the Global Sustainable Development Report. Prof Schein attend the session on "Review of SDG Implementation and Interrelations among Goals: Discussion on SDG 8 – Decent Work and Economic Growth".

A CSEND delegation workshop was also organised on the 21st July to exchange experiences and to discuss various thematic issues that the team is advocating. It was hosted by Prof Judith Parker at the Manhattan Club in New York.

Ninth Working Session of the Open-Ended Working Group on Ageing was scheduled to take place on these dates. A preparatory workshop by the NGO Committee on Ageing took place on the 22nd July. During the Working Session, CSEND presented a verbal statement from the floor in addition to the submission of a written text addressing the need to ensure the rights of the older persons' continued gainful participation in the labour market and in enterprise development during different stages of the life course.

A second statement was distributed on the floor calling for space making and intergenerational cooperative housing for sustainable ageing, inclusive communities and autonomy and independence of older persons.

The 2019 Academy of Management Annual Conference took place in Boston, USA, with the theme, "Understanding the Inclusive Organisations". CSEND representatives attended different sessions during the AOM annual conference. More than 11000 participants attended the conference.

 CSEND co-organised a Professional Development Workshop (PDW) on the 10th August focusing on "Creating Inclusive Organisations through Shared



- Ownership, Participation and Profits." Prof Frank Shipper of Salisbury University and Prof Raymond Saner of CSEND co-chaired this PDW. A total of eight presentations were made.
- Prof Raymond Saner and Prof Lichia Yiu made a presentation on "Impact of ICT Technology on Community Participation in Refugee Camps". The key points of the presentation were to explore how ICT could be deployed to ensure the personal security, autonomy and dignity of the refugees in a camp setting.
- On the 11th August, CSEND representatives participated in a one-day conference on "State Capitalism and the Firm", organized the Northeastern University. During the conference, researchers from different countries discussed the advantages of state capitalism, such as China, in the global market and implications for economic competitions.

CSEND Representative, Kala Madhav, attended NGO Committee on Status of Women (NGO CSW), Geneva meeting. (https://ngocsw-geneva.ch/)

Ms. Kala Madhav represented CSEND and attended the Context Gaps and the Human Rights Imperative for Older Persons – in & beyond humanitarian emergencies during the conference of the UN Human Rights Council. An update was made to the status report (2013) on "The Protection of Human Rights in Humanitarian Crises, A Joint Background Paper by OHCHR and UNHCR.

CSEND joined the NIIA delegation (Chengdu) to participate in the 2nd International Seminar on the Active Ageing Index in Bilbao, Spain. This seminar was jointly organised by the UNECE Population Ageing section, The Biscayan Regional Government, Universidad del Pais Vasco and the European Union.

At the WTO Public Forum 2019, CSEND together with the Geneva office of FAO organised session 24 which was titled "Services: a key enabler for agriculture trade". The session underlined the critical link between agricultural production, services and international trade performance. The disparity of the share of added value along the value chains are biased against the producers and favouring the intermediates and the lead firms. The session was moderated by Prof Saner and the panellists were Dr Christian Häberli, Senior Fellow, World Trade Institute, Dr Christian Kingombe, CEO, 4IP Group LLC (SARL), Geneva and Mr. Ahmad Mukhtar, Economist, FAO Liaison office Geneva. The session was well attended and responses from the floor were very positive.

Representative of CSEND, Kala Madhov joined the WHO Mental Health Forum to examine the ways and means to "Enhancing Country Action on Mental Health". It was of particular interest to note that WHO recently released a battery of products with the brand name of the "mhGAP Community Toolkit". During the Forum, country experiences in using the WHO tools were reflected.

CSEND representative participated in the 2019 World Trade Forum at the University of Bern which focused on the "Multilateralism at Risk". This forum was hosted by the World Trade Institute in collaboration with other partner organisations. A debate with the representative of Confederation of German Employers' Associations, Ms. Renate Hornung-Draus ensued regarding fair wage for the labour force. It was suggested by the CSEND representative that complementary to the proposed an "adequate minimum wage" in the ILC Centenary Declaration for the Future of Work, ILO needs to incorporate an "adequate maximum profit" policy. This debate took place during the Plenary Session V, "The ILO at 100, the Fourth Industrial Revolution, Trade and Employment".

CSEND representatives participated in the Twelfth Meeting of the Working Group on Ageing, Economic Commission for Europe. Three main points made during the meeting were: 1) International initiatives in the area of ageing; 2) Roadmap and guidelines for mainstreaming ageing; 3) Monitoring the implementation of Madrid International Plan of Action on ageing (2018). It was also discussed at the meeting of potential staff cuts in 2020.



Representatives of CSEND put forward a verbal motion supported by a written statement together with the Greycell Association on the need to set up an Expert Group on Ensuring Digital Inclusion and Digital Literacy of Ageing Population.

Ms. Kala Madhav represented CSEND and attended the Policy Seminar on Ageing, entitled "Informal Care for Persons with Dementia" (20 November). Dementia as the major health challenge for the ageing population would gain increasing significance for public policy. A concept note is available at https://www.unece.org/fileadmin/DAM/pau/age/PS2019/Policy_seminar_2019_concept_note_and_programme.pdf.

As a NGO observer of UNTFSSE, CSEND represented by Prof Lichia Yiu participated in the conference, entitled "The Social and Solidarity Economy Momentum: Finance for Inclusion and the Future of Work". Two large scale projects implemented by the ILO set the background of this Momentum conference; 1) Financial Mechanisms for Innovative Social and Solidarity Economy Ecosystems, and 2) Contribution of the Social and Solidarity Economy and of Social Finance to the Future of Work.

Cooperative movements have played a very important role in promoting economic growth, sustainable jobs and regional development for the



past 50 years. This momentum contributed to the poverty alleviation of the region and transformed it from an emigration location to a region of prosperity. EURICSE, a local government funded research organisation is actively promoting knowledge development and innovation for the field of cooperatives, social enterprises and other non-profit organisations engaged in the production of goods and services (https://www.euricse.eu/mission/).

The World Association of PPP Units and Professionals (WAPPP) organised an "Agenda 2 December 2019 Workshop for Permanent Missions". Prof Raymond Saner agreed to host the World Café II during the Workshop. The theme of this World Café was "Experiences of Mega Infrastructure PPPs".

(Taipei, China). Expert Roundtable on the Human Resource Requirements and Labor Demand in Support of Taiwan's Transition to Circular Economy through the Collection of Material Resources. This Roundtable was sponsored by the ILOSH of the Ministry of Labour. Presentations were made by experts from the China Economic Research Institute.

The Third Session of the Working Party on Public-Private Partnerships under the auspice of UNECE Committee on Innovation, Competitiveness and Public-Private Partnerships took place at the Palais des Nations. Discussions centred on how to implement People-first PPP Projects in Support of the SDGs. The lack of project management capacity within the government has hampered the development of fundable PPP projects. Similarly, missing proper funding model also slowed down the implementation.

(Taipei, China). ILOSH of Ministry of Labour invited Prof Lichia Yiu to participate in a Roundtable on Human Capital Formation and Enterprise Training. This Roundtable introduced the new standard ISO 30414: 2018, Human Resource Management – Guidelines for Internal and External Human Capital Reporting. The linkage with another training governance instrument, Taiwan Training Quality Standard (TTQS), which Prof Lichia Yiu was instrumental in its development, was also discussed.

Prof Virginia Schein attended the conference organised by UNOP on Sustainable Investment and the session on "Trends in Sustainable, Impact and ESG (Environmental, Social and Governance) Investing: Passive ESG Investing. It is doubtful that ESG portfolio would become the main investment vehicle and drive the necessary transition.

CSEND represented by Ms Kala Madhav joined the WHO Information Session for Non-State Actors. This session is important for the CSEND and its work on ageing since WHO does not recognise UN ECOSOC accreditation. Therefore, participation of non-state actors of the like CSEND is impossible, if not through some other WHO accredited peak NGOs.
