Profile of Instructors

Prof Raymond Saner

Raymond Saner is Titular professor at Basle University (Economics Department, 1988-present) and

teaches at Sciences Po, Paris (2005-) and has been a reviewer of research projects and partner of research consortia for the Swiss National Science Foundation and the International Institute of Administrative Sciences, Brussels. Raymond Saner is co-founder of CSEND, a Geneva based NGRDO (nongovernmental research and development organization, 1993-present), partner of Organizational Consultants Ltd Hong Kong (consulting company, 1989-present) and expert working for international organizations such as WTO, the WB, UNDP (United Nations Development Programme), EBRD (European Bank for Reconstruction and Development), ILO, UNICEF, BIS, government agencies from Switzerland, Sweden, Germany, Spain, China, Brazil, the Netherlands and the EU Commission (DG Trade). In regard to public affairs and public management, Raymond Saner has co-authored leading articles in the field of business diplomacy (Academy of Management Executive), international economic diplomacy (Diplomatic Studies, The Hague) and international negotiations (Books in German, French, English, Spanish, Portuguese). He teaches these subjects at diplomatic academies and as trainers for Ministries of Foreign Affairs in Europe, Asia and Latin America. He teaches and consults in English, French, German and Spanish. He lives in Geneva and Hong Kong and is frequently in China, USA and Latin America (Brazil and Bolivia) and Paris, France.

Dr Lichia Yiu

The academic research of Dr Lichia Yiu covers topics ranging from quality in in-service training, workforce development, organisational learning and change leadership to policy advocacy and evaluation. The most recent policy analyses were on higher education policy in China and Santa Catarina, Brazil, human capital development infrastructure in Taiwan, policy coherence in tourism development strategy in Least Developed Countries and private financing of global health in addition to the engagement of NGOs in the UN Post 2015 deliberation and aid effectiveness. Presently, she participates in a Swiss Network on International Studies (SNIS) project as a principle researcher focusing on the influence of private funding on the global public health policy and governance. This SNIS is due to be completed by April 2015. She is author of several books and many articles, reports and case studies on advocacy, poverty reduction and decent work, clean development mechanism, global leadership, quality in higher education and organisation development. She also serves as reviewer for the Journal of Management Psychology, Vision: The Journal of Business Perspective, and Gestalt Review.

Profile of Facilitators

Ellen Raider, MA

Ellen designed cross-cultural conflict resolution training programs for the worldwide staff of UNICEF, the American Friends' Service Committee, and the United States / USSR Trade Negotiation Project, jointly sponsored by the US National Science Foundation and the Soviet Academy of Foreign Trade. In response to a request in 1988, Ellen set up the training department of the research-based International Center for Cooperation and Conflict Resolution at Teacher's College Columbia University. In that capacity she taught graduate students in conflict resolution and created training materials for teachers, administrators, school boards, parents, and students in the United States, Canada and Macedonia. Ellen holds a Masters of Education Degree in Educational Psychology (Social and Group Processes) from Temple University. Over the past decade, she has been an advocate for a human rights-based system of public education for New York City.

Dr Roland Bardy

Executive Professor of General Management & Leadership at Florida Gulf Coast University, born in Vienna, Austria, studied chemistry and econometrics and worked for more than 30 years at BASF AG in leadership positions in finance and administration in Germany and Argentina. He published on philosophy and implementation of responsible leadership and accountability, leadership, business ethics, knowledge

management and sustainable development. He has published a book in 2014 titled "Sustainable Development in the Developing World" together with Maurizio Massaro and Arthur Rubens and together with Raymond Saner and Lichia Yiu in 2015 "Conceptualizing and Operationalizing Sustainable Development Goals through System Theory Perspectives", CSEND Working Paper No. 1/2015.
